## PRESIDENT'S REPORT – Mike Signorile: OPRA (Open Permit Request Application) S-2930

- S2930 states: The Legislature finds and declares it to be the public policy.
   of this State that government records shall be readily accessible for
   inspection, copying, or examination by the citizens of this State, with certain.
   exceptions, for the protection of the public interest, and any limitations on the
   right of access accorded by P.L.1963, c.7315 (C.47:1A-1 et seq.) as amended
   and supplemented, shall be construed in favor of the public's right of
   access...
- OPRA costs are astronomical. This bill adjusts the items available.
- Copy of S2930 attached.

## HR-7084 Petitions – You Earned It – You Keep It:

- Introduced in the House, Ways and Means, Energy and Commerce Committee on 1/16/24. Rep. Angie Craig (D-MN).
- This bill, if passed, will amend the Internal Revenue Code of 1986 to repeal the inclusion in gross income of social security benefits.
- All petitions received were sent to Senator Amato's Office.
- The 9<sup>th</sup> district is working on a stand-alone bill eliminating all of the added additions.
- Copy of HR-7084 can be obtained at Congress.gov.

#### **VICE PRESIDENT'S REPORT – Vince DeChiaro:**

The Coalition is great for bouncing ideas and solutions off of each other.

- HOA Pools: I will be contacting each Association after the pool season to gather information such as pool hours, children's hours, do you have monitors, your pool management company, who does your grounding, do you allow alcohol, age of children permitted, do homeowners/guests/tenants need to show badge, sign in, etc. Discussion to take place after the pool season for ideas and solutions for those having difficulties.
  - **HC West:** We eliminated sign in. Our gates are equipped with Face Recognition. We have a new chemical system that measures the chemicals and temperature and adjusts accordingly. If there is a problem we are notified immediately. This is working out great and saving us dollars.

#### **Coalition Website:**

• The garbage and recycling schedules were incorrect in several HOA newsletters and websites. Bill is aware and will correcting them on our website.

## Holiday City Carefree - Marie Perchelli:

We learned the hard way and offer the following as suggestions:

- **Elections:** Many trustees are voted in based on popularity rather than knowledge and experience. Board members should have knowledge of federal, state, and local laws, as well as a good working knowledge of association CCRs, Bylaws and Rules and Regulations.
- **Bylaw and CCR changes**: Be sure your community votes on these changes. I do not recommend using the 10% vote and found that the 2/3<sup>rd</sup> vote is better.
- **Reserve Study:** Appropriate capital reserve funding is a must. We established a Financial Advisory Committee. We are finally solvent and compliant with laws.
- **Trustees:** Our bylaws do not discuss carrier insurance. We bonded all of our trustees.

## **AARP Safe Driving Classes:**

6-hour course designed for senior drivers.

• Several Coalition members completed the six-hour on-line course designed for senior drivers.

- Once you complete your course, send the certificate to your insurance. Your insurance will be discounted and/or you will receive a reimbursement check.
- Completion of the course could reduce your points.
- Bob is taking the instructor's certification course. Upon completion he will be able to conduct classes for our Associations.
